## **Exams**

In April 2016, we had 14 students writing 20 exams in total in Vancouver during the April exam; and 13 students writing a total of 17 exams in Montreal. Results of these exams will be released on Aug 4, 2016.

The 2016 November exams will be held from Nov 14 to Nov 24. Registration for November exams will be closed by Oct 19. Results will be released on Feb 16, 2017.

2017 May exams will be held from May 8 to May 18. Registration for May exams will be closed Apr 3. Results will be leased on Aug 10, 2017.

In particular, they gave advice on how to read the questions and formulate answers and highlighted key concepts and suggested examples for each question topic. ICS hopes that the students came away from the sessions feeling better prepared.
